The data will be processed exclusively by enGenome S.r.l. employees and partners or companies expressly designated as data processor (for example IT company with the aim to website maintenance or storage) and can be freely transferred outside the national territory to countries located within the European Union and/or to extra-EU countries, subject to the verification of their use of adequacy standards regarding the protection of personal data.
